MINUTES WA OILSEEDS COMMISSION MEETING Tuesday, July 3, 2023 Conference Call

Call to Order: The meeting was called to order by Chair Jesse Brunner at 9:01 a.m. Those in attendance were Commissioners: Mike Stubbs, Justin Camp, Jesse Brunner, and WSDA Representative Paula Moore. Administrator: Shane Johnson.

Also in attendance were Karen Sowers, PNWCA; Ian Burke, Washington State University.

Review and Approval of Minutes: Shane Johnson presented the minutes from the April 18, 2023 Commission Meeting. <u>Mike Stubbs moved, and Justin Camp seconded the motion to approve the</u> <u>minutes from the April 18, 2023 Commission meeting as presented.</u> The motion passed unanimously.

Review and Approval of Financial Statements: Shane Johnson presented the Year End Profit and Loss Financial Statements from June 1, 2022 – May 31, 2023. The income from June 1, 2022 – May 31, 2023 totaled \$197,560.33 with expenses of \$183,670.73, giving the Commission a net income of \$13,889.60. The Balance Sheet on May 31, 2023 showed an ending balance of cash assets of \$459,870.94.

Shane then reviewed the Interim Financial Statement through June 28, 2023. There has been limited income of \$3,816.89 and expense of \$1,685.62, giving the Commission a net income of \$2,131.27. The balance sheet as of June 28, 2023, showed total assets of \$462,002.21. Shane then presented the check disbursements from 3357-3360 in addition to the associated bank fees for April and May. <u>Mike Stubbs moved, and Justin Camp seconded the motion to approve the financial reports and check detail as presented.</u> The motion passed unanimously.

Research: The commissioners then had the opportunity to discuss the research priorities and needs for the oilseed industry. The 2023-2024 RFP priorities were presented. Shane will email out to the group for further comment. The RFP will then be sent out in early to mid-September.

- WSDA Seed Program: Paula Moore gave an update on the activities of the WSDA Seed Lab.
